

Terms and Conditions for LaserFlight consolidated shipments of Rosenthal-Flugmodelle products

The following is a list of terms and conditions you must agree to via a signed and returned copy of this document.

The terms of the offer are as follows:

The transfer of moneys for all orders will occur in two steps.

- 1). At time of order placement, your payment to LaserFlight will be the prices listed in the attached price list. See terms 7 and 8 for details on payment.
- 2). The second transfer of moneys will be for the pro-rated shipment charges from Europe to the US PLUS the domestic shipment and packaging charges to your final shipment destination. You will have 14 calendar days to make the final payment for shipping charges after I notify you of product receipt. Failure to comply to this requirement will trigger LaserFlight to dispose of your product at our cost to another buyer and you will forfeit all moneys paid. LaserFlight does not have the warehousing facilities to store products beyond 14 days and we will dispose of unclaimed product accordingly.
- 3). I will manage all wire transfers to Europe and all packaging and shipment requirements here in the US. Once I have received the pro-rated Europe to US shipment fees as well as the domestic packaging and shipment fees, I will ship to your destination once the product has been received and term 1 and 2 have been met.
- 4). All orders are final at receipt of payment for product AND placement of order to Rosenthal-Fulgmodelle. You will be expected to complete the transaction with the shipping charges prior to final shipment to you per term 2 above. Cancellation AFTER the order has been placed will result in a forfeit of product order payments because your order will be part of a larger consolidation of product and shipment charges so please make sure you are committed to the order before placing it. There will be no refunds after the order is placed on Rosenthal Flugmodelle. This is a shipment consolidation service only with the goal of reducing shipment fees to you.
- 5). If you choose to cancel an order AFTER the order has been placed, LaserFlight will dispose of excess product at our own discretion and term 4 applies.
- 6). Orders will ONLY be placed on Rosenthal Flugmodelle when there are sufficient individual orders to fill one or multiple crates for shipment. Please note that this action MAY result in a delay in you receiving product. In order to keep shipment costs to you at a minimum, under normal circumstances, only full crates of product will be ordered and shipped. However, if there are insufficient product orders placed to fill a crate, I will provide those builders that have placed orders the opportunity to decide if they wish to wait on orders for a full shipment OR to proceed with the partial shipment. All parties must agree. If all parties do not agree, the order will be held until sufficient orders are available for a complete, full shipment.
- 7). Orders will be taken by me via PayPal in US dollars only.

8). Please place your order to me directly via email to sales@laserflight.com. I will respond with an invoice for your product order based on the prices contained in the attached price list.

9). LaserFlight requires that you sign and return to us via fax and concurrently, via US mail, a signed document signifying your agreement to these terms PRIOR to order placement on Rosenthal Flugmodelle. This is to ensure you have read and agree to the terms as well as to protect LaserFlight from legal action if you fail to meet the terms of the agreement. A standard warranties and liability disclaimer will be added to these terms.

10). Shipping damage claims due to shipment damages between Europe and the US will be managed by LaserFlight. If they occur, they will likely to impact the speed at which I can fulfill your order since a replacement order will be required and will only be made after the carrier has funded such replacement.

11). Shipping damages for domestic shipments will be handled between the purchaser, you, and the carrier direct.

12). All shipments are final. We will not take returns.
